A unified MPA database for all UK seas



- Ocean Devotion: MPAs that work
 - Engages the general public in MPA processes through an easily understandable interactive map
 - Holistic campaign looking at all types of MPA designations in all UK countries
 - Requires a comprehensive MPA dataset
- Existing interactive mapping resources are too technical for general public, and yet do not provide access to back-end databases that could support those working on MPAs
- Need to know where to look and what to look for (data sources, formats, content)



A unified MPA database for all UK seas



- MCS SQL database import disparate spreadsheets & shapefiles into one central data source (excluding PDFs and some spreadsheets)
- Major project, especially field mapping, dataset preparation – particularly where metadata is missing (e.g. map projections)
- Ongoing project, but now provides the back-end for the interactive public engagement map, as well as a central resource for staff
- Keen to hear of similar projects, or ideas that could support this work or be supported by it


















Marine Protected Area Management National Steering Group
