#### **MSFD** requirements

The Marine Strategy Framework Directive:

- requires Member States to put in place measures to achieve Good Environmental Status (GES) in their marine waters by 2020.
- requires MS to cooperate to ensure that the measures required to achieve GES are coherent and coordinated across the marine region or sub-region

Supports UK Government and Devolved Administrations' vision for "clean, healthy, safe, productive and biologically diverse oceans and seas"

1	Biological diversity maintained
2	Non-indigenous species
3	Commercial fish & shellfish
4	Food-webs
5	Eutrophication
6	Sea-floor integrity
7	Hydrography
8	Contaminants
9	Contaminants in seafood
10	Litter
11	Energy, incl. underwater noise

#### Habitats monitoring

Strategy for habitat monitoring being developed

National monitoring for non-CFP stocks

Shellfish monitoring will take the form of stock assessments



#### **Other approaches**



Track and record licensing applications to identify of any proposed developments large enough to have the potential to alter hydrographical conditions

Build on previous retail surveys of seafood and enhance with new investigations into contaminant levels in seafood extracted
